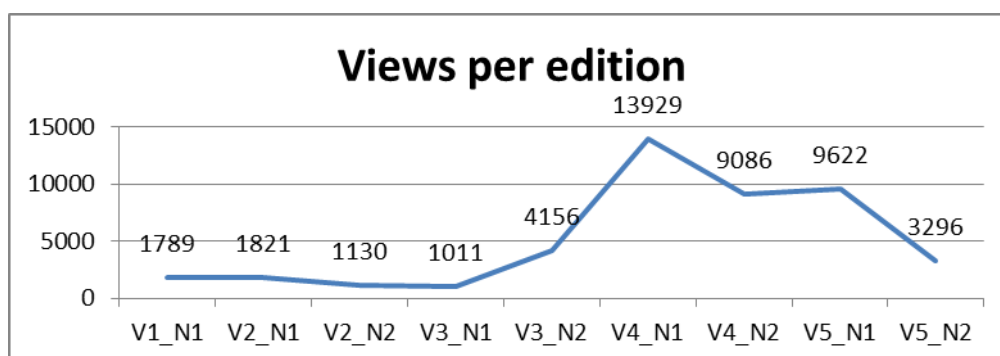


Figure 1: Quantity of viewing by volume/number

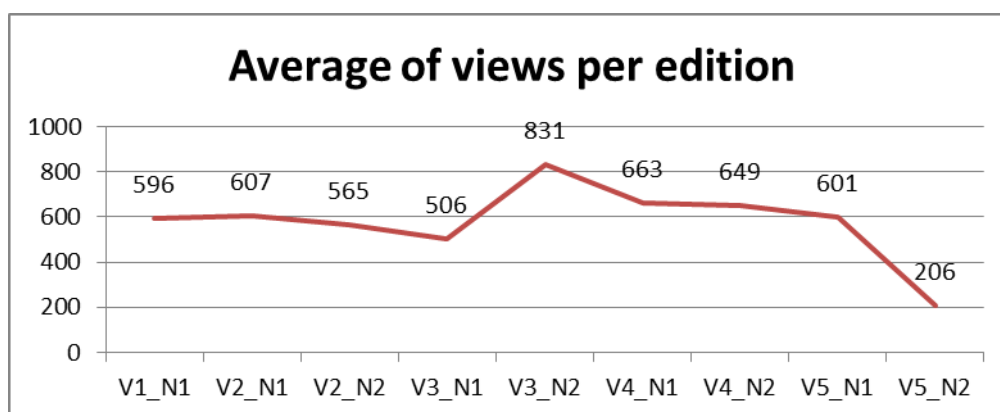


Figure 2: Average views by volume/number

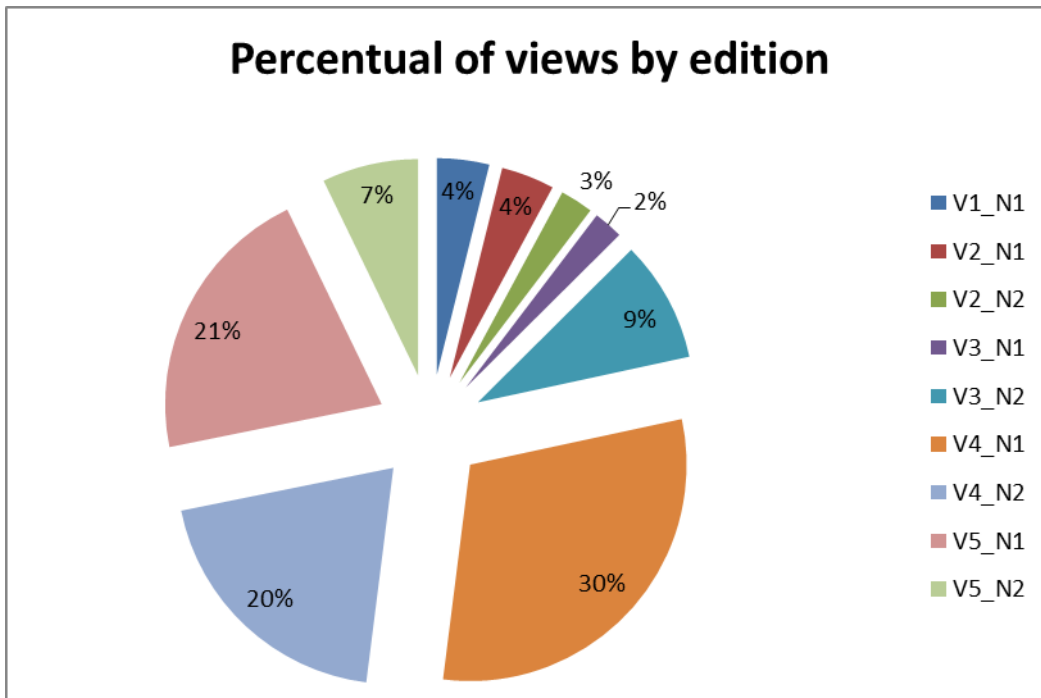


Figure 3: Percentage of viewing by volume/number

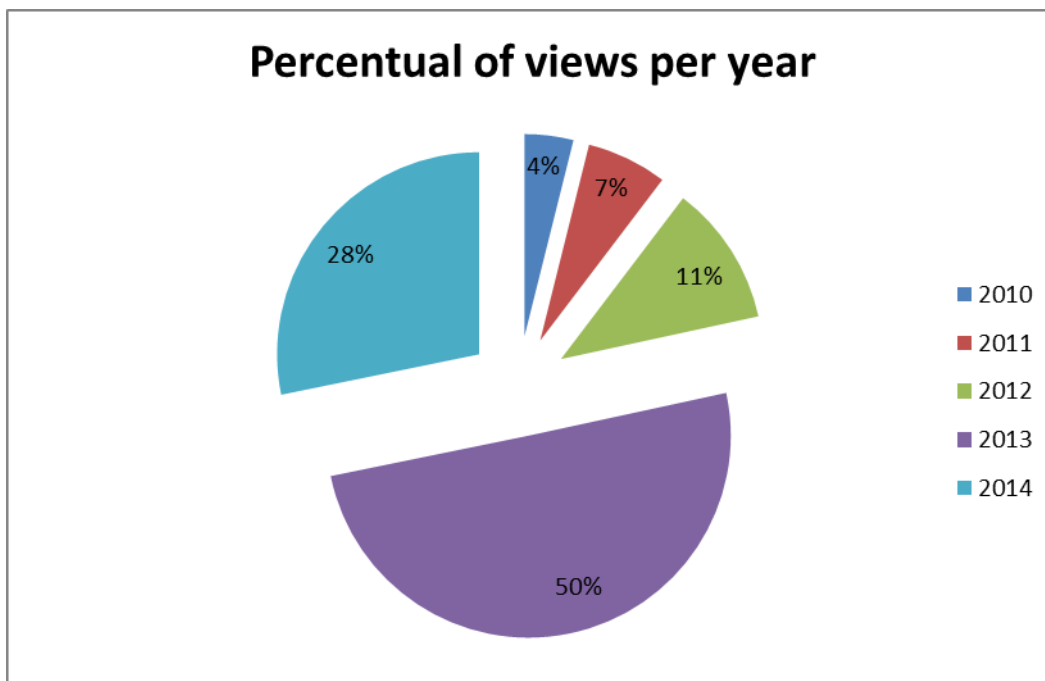


Figure 4: Percentage of viewing by year

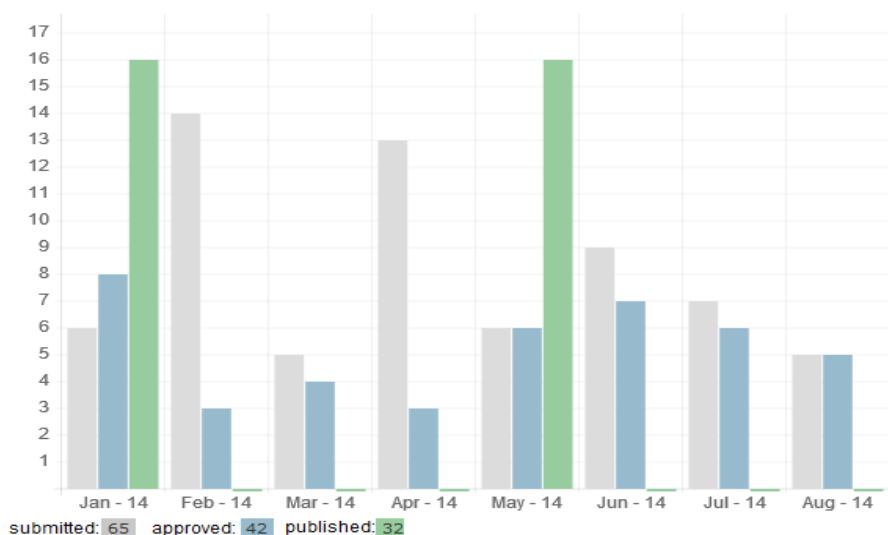


Figure 5: Status of the editorial process articles submitted x approved x published

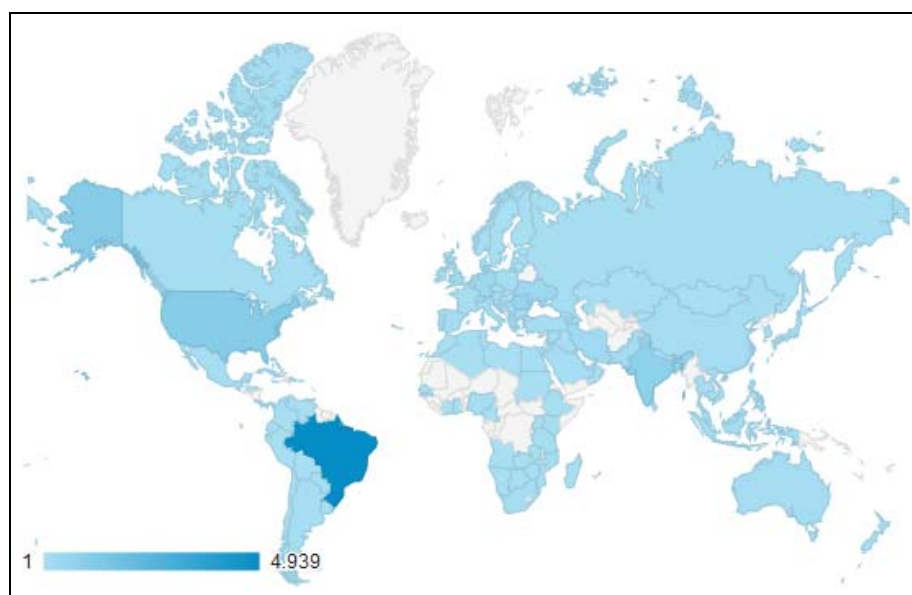


Figure 6: Countries that have accessed the journal

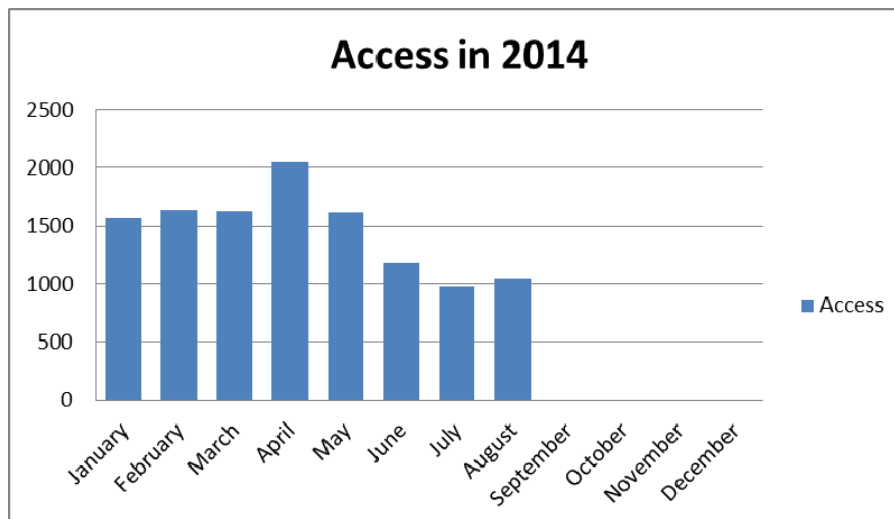


Figure 7: amount of hits between January and August
